Dietary management of fibromyalgia caused by DAO deficiency

- Contains DAO ENZYME (Diamine Oxidase). Also contains magnesium that acts as adjuvant on the dietary management of fibromyalgia caused by DAO deficiency.
- The active ingredient is a Novel Food according to the EU Regulation 2015/2283.
- Acts metabolizing ingested histamine in the diet, preventing its accumulation in the blood and avoiding the appearance of fibromyalgia, pain and muscle contractures and osteopathic pain.
- **Restore the optimal activity DAO levels** thanks to its structural and functional equivalence with the human DAO, avoiding histamine absorption.
- The DAO enzyme contained in fibroDAO[®] presents an enzymatic activity of >0,41 mU per capsule (>20.000 HDU)

What is DAO?

DAO is the main enzyme for the metabolism of ingested histamine. It is mainly located in the intestinal epithelium, where it absorbs and degrades the ingested histamine preventing it from passing into the bloodstream.

What is histamine?

Histamine is an essential molecule, a transmitter that belongs to the so called group of biogenic amines and that is naturally present in many foods as well as inside of our cells. Normally, the intake of histamine contained in food does not cause any problem, since it is quickly processed and metabolized by the Diamine Oxidase enzyme (DAO).

What is DAO deficiency?


It refers to a deficiency in DAO metabolization activity or when there is an imbalance between the ingested histamine and the enzyme capacity to metabolize it. As histamine has not been properly metabolized and degraded, it passes into de blood-stream triggering different symptoms. The most common symptomatology of DAO deficiency is:

- Fibromyalgia, pain and muscle contractures and osteopathic pain.
- Digestive disorders such as bloated feeling, flatulence, constipation or diarrhoea.
- Skin disorders, such as dry or atopic skin.
- Non-allergic rhinitis.
- Tinnitus.
- Migraine and other headaches.

How does fibroDAO® work?

The DAO contained in fibroDAO[®] serves as a supplement to the enzyme found in the body, which oversees metabolizing histamine. Taking one capsule of fibroDAO[®] before each meal increases the amount of DAO in the small bowel and therefore also boosts histamine degradation. This accelerates the processing of the histamine found in different foods in the diges-tive tract, which triggers the symptoms.

The DAO enzyme contained in fibroDAO[®] acts only in the intestine, is not absorbed and has no systemic activity, hence it is considered a harmless product with no adverse effects.

What does fibroDAO® contain?

INGREDIENTS: Bulking agents: Microcrystalline cellulose and Hydroxypropyl cellulose; magnesium oxide (magnesium); potato starch; Glazing agents: Ethyl cellulose and hydroxypropyl methylcellulose; Protein extract from pig kidneys with 7% Diamine Oxidase (DAO); rice starch; Stabilisers: Magnesium salts of fatty acids, Alginate sodium and stearic acid; Medium-chain triglycerides and oleic acid; Glazing agent dicalcium phosphate; concentrated apple, blackcurrant, and radish, spirulina and apple. Vegetable capsule: Hydroxypropyl methylcellulose fibroDAO[®] Eficaps[®] capsules contain gastro-resistant tablets with controlled release DAO in the intestine that prevent stomach acid pH and tablets that guarantee the immediate release of adjuvant active ingredients.

Each capsule contains four tablets:

- 2 DAO white/beige gastro-resistant tablets with release into the intestine
- 2 purple tablets for immediate release with magnesium

How should fibroDAO® be used?

The capsule should be swallowed whole with some water, 20 minutes before the main meals (3 times a day). If you are unable to swallow it whole, please open it and ingest the tablets from its interior separately, swallowing them whole without chewing, splitting or breaking them.

Conservation

fibroDAO[®] contains DAO, a thermolabile enzyme (sensitive to temperature), being advisable to keep it away from sources of heat. If consumed according to the dose recommended daily intake, does not require a special conservation, but if exceptionally consumes sporadically, being stored for long time, it is advisable to keep it in fridge.
